RANGE ACTION SAFETY PLAN

(RASP)

General

1. In accordance with reference A, Killingholme Club will fire at the Range between 9.00 hours and 21.00 hours on any day provided that there is sufficient light and it is deemed safe to do so by the Acting Range Conducting Officer (RCO) as signed in on the Range Log situated in the Steel Hut.

Aim

2. The aim of the range period is to allow members and guests to conduct shooting by competition and practice in a safe and proper manner in accordance with National/Club Rules and Legislation.

Range Booking

2. No Booking is required; however, competition shooting takes presidency over all other classes of shooting.

Range Conduct

4. All firing is to be conducted in accordance with the conditions in Reference A, and under the rules and Regulations laid down in references A B and C.

Staff Duties

5. The Staff nominated in the Range Register are to carry out duties shown against their names i.e. Acting Range Conducting Officer.

Course of Fire

6. Will be displayed on the club Notice board as Competitions or as decided by the Acting RCO in the absence of such activities.

TIME AND PLACE OF ASSEMBLY

7. Firers. On arrival in the Steel Hut.

Range Staff. Range Staff to be nominated by the RCO unless detailed otherwise.

DRESS AND EQUIPMENT

8. All firers, Range Staff and any other person's present must be in possession and wear adequate ear defenders and eye protection is strongly recommended to be worn at all times when at the Firing Point.

AMMUNITION

9. All ammunition used must fall within the velocity and energy limits set out in Range Orders. If hand loaded ammunition is to be used, the firer must be able to supply to the Acting RCO, on request, a full loading specification.

10. Firers are responsible for the safety and security of their powder and ammunition and the removal of any live rounds, powder or fired cases from the range. Discarded brass is to be deposited in the secure bin provided at the Covered Firing Point.

RANGE STORES AND RIGGING

11. Club Members are responsible for obtaining targets from the Steel Hut or for supplying their own target in accordance with the Club Rules.

WEAPONS

12. Firers are responsible for the security of their firearms.

TRANSPORT

13. All vehicles will be parked properly on the car park or as instructed by the Acting RCO and are at the sole risk of the owner.

FIRST AID AND MEDICAL COVER

14. Emergency and First Aid cover is to be provided by the Emergency Services as necessary and it is the responsibility of the Acting RCO to call for such help.

(A First Aid Box is provided in the Steel Hut)
